### ***My five most important publications (with explanations)***

Berlin: Verlag für Wissenschaft und Forschung [monography, 520 pages].

This is my Doctoral thesis published as a book. It is significant because it is an early work on which I have spent more time than on any other publication. Besides, its findings are still relevant and interesting.

This article provides not only a synoptic view of different forms of regulation. It is also a synopsis of about 10 years of my own research on governance issues in the public and the private domain (therefore, it was originally the framework paper of my Habilitation). The article received the Harold D. Lasswell Prize as the “best article in Policy Sciences that contributes most to the theory and practice of the policy sciences” in 2013, as determined by a vote of the journal’s international editorial board.
