# of the City of Vienna for the University of Natural Resources and Life Sciences (BOKU), Vienna

With the establishment of the "Anniversary Fund of the City of Vienna for the University of Natural Resources and Life Sciences (BOKU), Vienna," the City of Vienna celebrates the 150th anniversary of BOKU in 2025 and acknowledges the cooperation with one of Vienna's most important universities.

Through the joint and coordinated approach to addressing key issues by BOKU University and the City of Vienna, the synergies between science and industry are aimed to be actively promoted.

### The established fund serves the following objectives

- Strengthening science-based collaboration in core areas between the City of Vienna and the University of Natural Resources and Life Sciences (BOKU), Vienna
- Reinforcing collaboration between science and industry in the areas of competence of BOKU, integrated with the business fields of the City of Vienna
- Promoting the connection between business and sustainable development, thereby strengthening the economy and quality of life in Vienna
- Strengthening the university and scientific location of Vienna by targeting the integration of activities between BOKU and the City of Vienna
- promoting young scientists at BOKU University

#### The following funding instruments are available:

- I. City of Vienna-BOKU Research Funding
- II. BOKU Best Paper Awards
- III. BOKU Talent Awards (for outstanding Master's theses or dissertations)

In the "City of Vienna-BOKU Research Funding" instrument, research projects from all fields of BOKU, focusing on the theme: "(Viennese) Paths into the Future: Sustainable and Resilient Supply Systems in a Societal Transformation," will be supported in 2025.

The "BOKU Best Paper Awards" and "BOKU Talent Awards" will honor submissions from all fields of BOKU.

#### I. City of Vienna-BOKU Research Funding:

As part of the City of Vienna-BOKU Research Funding 2025, research projects from all areas of BOKU, in conjunction with the focus on "(Viennese) Paths into the Future: Sustainable and Resilient Supply Systems in a Societal Transformation," can receive funding ranging from €35,000 to €90,000, with a project duration of a maximum of 2 years. A total of up to €175,000 will be available for the "City of Vienna-BOKU Research Funding" projects.

Submitted projects should contribute to the vision of a sustainable metropolitan region, particularly addressing the institutional and technical design of various supply systems (e.g., in the areas of food, mobility, housing, energy), making them resilient to acute ecological and political challenges.

The projects should focus on ecological and social sustainability dimensions of supply systems and contribute to developing positive narratives and solutions in the current societal transformation.

It may include **a variety of topics**, for example mobility, biodiversity, nutrition, agriculture and forestry, sealing, supply and disposal, energy provision, natural resource use, health, and recreation. The projects must have a reference to Vienna and should align with the context of the SDGs. Projects related to the "Vienna 2030 – Economy and Innovation" strategy, the "Smart Climate City Strategy Vienna," or current city projects are especially welcome.

Interdisciplinarity is also encouraged. Stakeholder involvement in an appropriate context will be positively evaluated, and its relevance must be briefly outlined in the application.

In accordance with the strategic principles outlined in BOKU's development plan, the research projects should be designed and carried out with a strong focus on scientific quality and sustainability criteria (see <u>BOKU's sustainability webpage</u>).

As the fund aims to support early-career researchers, all BOKU researchers who meet the following criteria are eligible to apply:

- Doctoral degree obtained no more than seven years ago (parental leave and maternity protection periods are not counted)
- Employment contract with BOKU for at least 20 hours per week
- Documented scientific experience

Associate Professors and appointed Professors are not eligible to apply. The project must be primarily conducted at BOKU.

#### The following documents are required:

#### 1) Project description, including

- Short summary for public communication in German (max. 1 A4 page)
- Scientific abstract in German and English (max. 1/2 page each)
- Detailed description of the planned research in English (5 to 8 pages excluding references):
   Research question, state of the art, previous work, project objectives, and innovation, detailed work plan with methodology, contribution to SDGs
- If applicable, reference to the City of Vienna's relevant business areas (approx. 1 page); an expression of interest from the respective business area is welcome

- Timeline and cost plan: The funding may cover personnel, material, and travel costs associated with the project. Transitional funding for PhD candidates is not allowed. If a PhD candidate is involved, it is expected that they will be engaged for the majority or entire project duration.
- 2) Cost calculation Table, see www.boku.ac.at/fos-researchfunding.html
- 3) **Detailed Curriculum Vitae** including a list of publications and a description of the scientific competence and the previous societal impact of the applicant's research, particularly in the field of the application.
- 4) Proposal of at least ten potential, exclusively international reviewers, ensuring that any possible conflicts of interest are carefully avoided (for details, see the application form).

Please submit the electronic project notification (ePM) two weeks before the deadline.

Note: For a complete submission, the release via ePM is absolutely required!

#### II. BOKU Best Paper Awards

Each year, a maximum of five top publications from BOKU may be awarded a prize of €1,500 each. Publications from all subject areas of BOKU are eligible for submission.

PhD students, graduates, and young researchers from BOKU who have completed their doctorate within the last seven years are invited to apply. The author who has contributed predominantly to the work is eligible to apply. The publication must have been primarily developed at BOKU and published or accepted for publication since 2023.

**Application documents** must be sent in digital form as a single PDF document (max. 20 MB) to <a href="mailto:researchfunds@boku.ac.at">researchfunds@boku.ac.at</a> using the application form:

- 1) Application form: Download from www.boku.ac.at/fos-paperawards.html
- 2) A scientific original paper published or accepted for publication in a peer-reviewed and renowned international journal
- 3) Justification for the award worthiness of the publication (max. one A4 page)
- 4) Detailed CV, including a list of publications
- 5) In the case of a multi-author publication, a concrete description of the applicant's contribution must also be submitted, as well as a signed confirmation from the applicant that the approval of all co-authors for submitting the publication has been obtained.

#### III. BOKU Talent Awards (for excellent Master's theses or dissertations)

Each year, prizes are awarded for outstanding scientific theses from all subject areas of BOKU.

A maximum of five Master's theses will be awarded a prize of €1,500 each, and a maximum of three dissertations will be awarded €3,000 each. The theses must have been approved at BOKU since 2023.

**Application documents** must be sent in digital form as a single PDF document (max. 20 MB) to researchfunds@boku.ac.at using the application form:

- 5) Statement from the supervisor on the award worthiness of the thesis
- 6) Certificate of Master's or PhD completion at BOKU
- 7) Master's thesis or dissertation

## Information on the processing of personal data
