The ethics platform



- Established 2011, part of the senate
- Around 55 members; representants of the senate, the rectorate, of the departments and the centers (IDR, gWN, ZfB), ÖH BOKU and the employee representative councils
- The ethics platform is a discourse forum enabling and supporting systematic participative and constructive reflection regarding actions taken at BOKU. Main tasks are:
 - Identification, awareness raising and discussion of ethical questions related to BOKU's actions and ongoing development of ethical guidelines related to research, teaching and dealing with each other
 - Planning of public events: talks, discussion, training related to ethical topics
 - Initiation and coordination of working groups dealing with BOKU specific ethics topics; Publishing position papers supporting the opinion formation at BOKU; Identifying potential need for discussion related to work being done at BOKU; Upon need, discussion of ethical aspects in intended research; Supporting public relations work; Website; Ethics-networking

The ethics committee



- Established in October 2020, based on section C1 of the BOKU Statute
- BOKU researchers can submit an application if they need an ethics statement, e.g. for:
 - Submitting a project proposal → Requirement of the funding agency
 - Submitting a manuscript → Requirement of the journal
- The ethics committee issues statements based on an assessment of the submitted application:
 - For research projects involving human subjects: ensuring that the rights, the safety, and the well-being of participants are adequately protected
 - For research projects involving animals: ensuring that the provisions for the implementation of the animal welfare law are adequate

The animal-welfare body



- Established in 2013: According to Tierversuchsgesetz 2012 (§21 TVG 2012)
 - Every university as "user" performing animal experimentation must set up an animal-welfare body
- Tasks of the BOKU animal-welfare body
 - Giving advice on animal welfare (acquisition, accommodation, care and use)
 - Advising staff on replacement, reduction and refinement (3Rs) in animal experimentation: replace and reduce the use of animals, refine conditions, promote alternatives to animal experimentation, reduce pain, suffering, distress or lasting harm to the animals
 - Giving advisory opinion on the application for project authorization
 - Following the development and outcome of projects
