This document is a regulation of the 1st Scientific Conference "Agriculture of the 21st century - problems and challenges" which will be held on 30-31st of March 2016 in the International Conference Centre "Krzyżowa".

General provisions

Throughout following definitions, used in present regulation there shall be understood:

- **Organizer**: Idea Knowledge Future, Kardynała Stefana Wyszyńskiego 103/15 street. 50-307 Wrocław
- **Participant**: a person who makes registration through sending a form facilitated by an Organizer

Rules of the present regulation are an integral part of conference the registration form and are obligatory for all Participants.

Sending a registration form to the Organizer is tantamount to an acceptance of the present regulation by the Participant and is a form of transaction of commitment between Parties.

Rules of participation

Terms of participation on the 1st Scientific Conference "Agriculture of the 21st century - problems and challenges" are as follows:

- 1. Accomplishment of all statements given below:
 - filling an online form available in the Organizer's webpage
 - after registration through an online form, the Organizer undertakes to confirm a registration, in case of lack of information concerning registration participants-to-be are asked to contact with the Organizer by e-mails.
 - doing a payment within 7 days since the registration of participation in the Conference into the Organizer's bank account; in case the Participant does not pay for registration in an appointed term will be automatically deleted from the list of Participants.
 - the Participant will be informed about completing all formalities by e-mail.
- 2. The Organizer is entitled not to give a permission to participate in the Conference without giving a reason.
- 3. Number of participants in the Conference is limited, order of registration is a determinative factor.
- 4. In case of resignation of the Participant the Organizer is entitled to keep all registration payment.
- 5. The Organizer reserves the right to countermand the Conference in case of unexpected events then all payments will be given back to the Participants.

The Conference

- 1. The conference will be held on 30-31st of March 2016.
- 2. The right of participation in the Conference is owed to: scientific workers, doctoral students, students, company representatives and people interested in subject of the Conference.
- 3. Deliberations are held in thematic blocks, time of performance in form of report should not exceed 10 minutes, in form of multimedia poster presentation (containing maximum 6 slides) should not

exceed 5 minutes. After performance or posters presentation done by all Participants, there is predicted time for discussion.

- 4. The Organizer has a right to make changes in a schedule even on the day of the event, including changing an order of performance and a timetable.
- 5. The Organizer does not take responsibility for material assets of the Participants.
- 6. The participants take all material responsibility for made demolitions in area of the object where the Conference will be held.
- 7. The Participant undertakes to follow safety rules including fire and the Organizer's technical and organizational commands.

Publication in a monography

- 1. All Participants have a possibility of publication their elaborations in a form of chapter in a scientific monograph after fulfilling requirements given in the Organizer's webpage. Full content of an article, formatted appropriately according to an example available on the Organizer's webpage should be sent to: <u>kontakt@konferencja-rolnictwo.pl</u> at term coincident with a schedule given in the Organizer's webpage.
- 2. Condition of publication of elaborations in monographies is accomplishment of editorial requirements and positive review sent by a scientific worker.
- 3. We reserve the right to mark corrections in sent elaborations without a necessity of consultation with their authors.
- 4. An author is obliged to make on-time possible corrections and changes in an elaborations pointed by the Organizer.
- 5. Non-compliance of terms of sending elaborations and editorial requirements will result in no acceptance to publish them.

Final provisions

- 1. Course of the Conference may be filmed or photographed by the Organizer.
- 2. Participation in the Conference is tantamount to devolving on the Organizer authorial financial rights concerning recordings and photographs and agreement to commercial use by Idea Knowledge Future: it concerns situations when the Participant is recorded or photographed in the Conference areas and when the Participant arbitrarily agrees to give an interview or pose in photographs.
- 3. Registration to the Conference is tantamount to a Participant's agreement to personal data processing made by the Organizer according to rules resulting from generally obligatory regulations, with particular consideration for the Personal Data Protection Act from 29th of August 1997 (the Journal of Laws No. 133, pos. 833 with later corrections).
- 4. The Organizer reserves the right to make changes in the present rules.
- 5. Any arguments concerning organization of registration are adjudged by the Director of Idea Knowledge Future.
- 6. The present rules comes into force on the day of publication in the Conference webpage.
